

# School Parent and Family Engagement Policy School Year 2024-25

## A. ANNUAL TITLE I MEETING

<u>Campus International High School</u> will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents and family members of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' and family members requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent and family compact.

#### **B. FLEXIBLE NUMBER OF MEETINGS**

<u>Campus International High School</u> will offer a flexible number of engagement meetings in accordance with the OPHAS level as outlined in Part A at convenient times for parents and families, such as meetings in the morning or evening (for which the school may use Title I funds to provide transportation, childcare or home visits, as such services relate to parent and family engagement (if the state's current OPHAS Level is 1).

- Campus International H.S will host monthly Chat-and-Chew parent meetings and various times based on parents' schedules/availability to update parents/guardians with valuable school, IB and scholar information.
- Parents will also be provided Zoom or Teams links to attend virtually if they cannot make it in person.

## C. JOINTLY DEVELOPED

<u>Campus International High School</u> will take the following actions to engage parents and families in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the schoolwide program plan.

• A parent or guardian from our PAC will be invited each year to sit on the planning team for the AAP and be given the opportunity to give input. Their signature will be obtained on the documents. The PAC will be used as a basic platform to develop and discuss family engagement including the development of the school parent compact and family engagement policy. Parent/Teacher conferences will be used as quality time to disseminate information about their scholar's academic performance, attendance, and behavior. This time will also be used to solicit ideas and suggestions from the parents on what type of activities and events they would like to see held at the school to secure their involvement.

## **D. COMMUNICATION**

<u>Campus international High School</u> will provide parents and families of participating children timely information about programs under Title I, including:

- a) a description and explanation of the curriculum in use,
- b) forms of academic assessment used to measure student progress,
- c) achievement levels of the challenging State academic standards, and
- d) if requested by parents and families, opportunities for regular meetings to formulate suggestions and participate, as appropriate, in decisions relating to the education of their children and respond to any such suggestions as soon as practicable possible.

Information related to the school and parent and family engagement programs, meetings, and other activities, will be provided to the parents and families of enrolled children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents and families can understand.

Monthly calendars will be developed with events listed for parents to participate in.

- Weekly newsletters with updates will be used as communication devices between parent/teacher, parent/administration.
- The school website, and other web-based communication tools such as: Clever, Schoology, Remind Texts, IVRs and flyers will also be used as a means of communication and a translator will be used when/if necessary.

#### E. DISSENSION PROCESS

<u>Campus International High School</u> will submit any comments/concerns to the CMSD Office of Family and Community Engagement if the schoolwide plan and/or parent and family engagement policy is not satisfactory to parents and family members.

#### F. SCHOOL-PARENT COMPACT

<u>Campus International High School</u> will take the following actions to jointly develop with parents and family members of enrolled children a school-parent and family compact that outlines how parents, families, school, staff, and students will share the responsibility for improved student academic achievement and develop a partnership to help children achieve the state's high standard and how the plan is used, reviewed, and updated.

• The PAC will be used as a basic platform to develop and discuss family engagement including the development of the school-parent compact. The compact will be shared with school staff for buy-in and input. The compact will also be made available to the student body leadership (Student Council) for review and input. Notice of the parent compact and opportunity to participate in its development will be offered through sharing the PAC meeting schedule and proposed agenda items prior to the meeting.
