



School Parent and Family Engagement Policy

A. ANNUAL TITLE I MEETING

Communication strategies will include the school's website, electronic newsletters, event calendars, social media, emails and robocalls. We will encourage teachers to post messages on the electronic grade book.

All communications will be available in Spanish.
