



School Parent and Family Engagement Policy School Year 2025-2026

In support of strengthening student academic achievement, Buhrer Dual Language Academy receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a parent and family engagement policy (written or posted on school website), agreed on by such parents and family members, that shall describe the means of carrying out the requirements of The Every Students Succeeds Act (ESSA) Section 1116. Buhrer Dual Language Academy agrees to implement the following requirements as outlined by ESSA Section 1116:

A. ANNUAL TITLE I MEETING

Buhrer Dual Language Academy will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents and family members of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' and family members requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent and family compact.

Considering ongoing concerns due to the Coronavirus (COVID-19), during the 2021\2022 school year, each school in the Cleveland Metropolitan School District will make the health and well-being of participants, staff, partners, and other guests a top

priority. During the 2021/2022 school year, all meetings will be held in alignment with the Ohio Public Health Advisory System (OPHAS) as follows:

- Level 1 – Meetings can be held in person or remotely. Any meetings held in person will be done with strict adherence to health and safety guidelines (handwashing, hand sanitizing, wearing masks and following social distance guidelines of at least 3ft), to ensure to the extent possible prevention of the spread of the virus.
- Level 2, 3, and 4 – All meetings will be held remotely and recorded to be posted on the school's website for viewing at a convenient time for all families, and staff.

B. FLEXIBLE NUMBER OF MEETINGS

Buhrer Dual Language Academy will offer a flexible number of engagement meetings in accordance with the OPHAS level as outlined in Part A at convenient times for parents and families, such as meetings in the morning or evening (for which the school may use Title I funds to provide transportation, childcare or home visits, as such services relate to parent and family engagement (if the state's current OPHAS Level is 1).

PAC meetings will take place at least once per month on the first Thursday of the month from 10:00 to 11:30am. FEC meetings will take place monthly and will consist of admin, teachers, and parents.

C. JOINTLY DEVELOPED

Buhrer Dual Language Academy will take the following actions to engage parents and families in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the schoolwide program plan.

- Educate school personnel, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents and families, in the value and utility of the contributions of parents and families, and in how to reach out to, communicate with, and work with parents and families as equal partners, implement and coordinate parent and family programs, and build ties between parents, families, and the school.
- Coordinate and integrate parental and family engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as family resource centers and materials that encourage and support parents and families to fully participate in the education of their children.

H. ACCESSIBILITY

- Every week, families of special education scholars are invited to review ETR and IEP information with a translator providing a platform to discuss concerns and ask questions.

- Teachers communicate with teachers via Microsoft 365 Outlook.
- Academic meetings with parents to communicate academic support.
- Every other Thursday, special education, meetings are scheduled with parents with translation support.
- Bilingual IVR and flyers for school events

E. DISSENSION PROCESS

Buhrer Dual Language Academy will submit any comments/concerns to the CMSD Office of Family and Community Engagement if the schoolwide plan and/or parent and family engagement policy is not satisfactory to parents and family members.

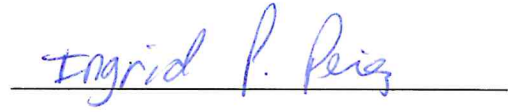
G. BUILD CAPACITY OF PARENTS

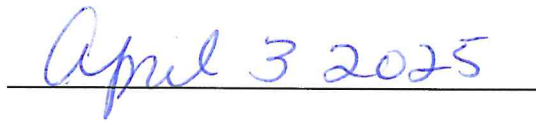

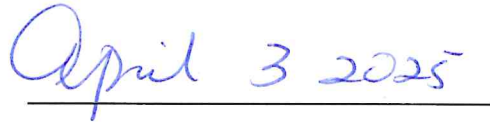
